Chad Clevenger met with the Missouri Department of Conservation's Community Forester. Discussion was held on trees, invasive species and companies that will remove them, planting new trees and tree programs. The MDC Cost Share Program was discussed. The Cost Share Program would help with the cost of purchasing trees, cost of invasive species removal, etc. Chad has ordered free trees for the parks. Tree City USA will also be researched.

Two employees will attend the Missouri Department of Conservation's Tree Keepers Class at the Anita B.Gorman Discovery Center in April.

There are many Parks and Recreation Departments that are having difficulties finding and retaining officials.
