The Siloam Springs Park signage will be installed on the large rock that Chad Clevenger secured for the park. Be on the lookout for an announcement for the Dedication Ceremony.

Nate Williams shared pictures through the years from 2016 to present at Boundless BackYard.

Nate Williams shared in the Board Packet, emails that he has been exchanging with Phillp Scherer in regards to building a single track dirt trail 24 - 30" wide for mountain biking and hiking. It would utilize: Phase 1: 105 acres between Golf Hill Drive and 10 highway; Phase 2: 38 acre tract north of Old Time Drive and Phase 3: 26 acres of Siloam Mountain Park. This trail system would be built and maintained mostly by volunteers.

There would be an insurance cost of \$700 annually through Urban Trail Company (UTC).

A Memo of Understanding (MOU) would need to be completed.

Downtown Excelsior Partnership (DEP) is interested in bringing back the Opal Wapoo Race, which would be similar users to the trail system.

In Phase 3, Chad Clevenger has concerns about the Isley Park Woods Natural Area and the backyards of houses.
