STAFF REPORT

Don Ledford asked about the porta potties in Century Bark and East Valley. The one in Century Bark will stay because the dog park is used and the one in East Valley will be evaluated.

Nate Williams posted on Facebook on December 15 before the snow arrived that at the "recommendation from our insurance provider along with current trends of other parks and recreation departments in the KC Metro area, ESPR has made the decision to not clear snow off of trails beginning with winter 2019. ESPR encourages community members to stick to safer sidewalks that have been cleared of snow". There were mixed reviews and one encouraged alternate activities – go snowshoeing or cross country skiing.

Zac Wilkins arrived at 1813 hours.

There were approximately 175 youth at the Candy Cane Hunt. Some gloves, scarves and one coat were donated for the drive.

There were approximately 60 dogs at the Paws for Pictures. 156 pounds of dry dog food were donated along with 180 cans of pet food. Toys and blankets were also collected. These things were donated to the Excelsior Springs Animal Shelter.

The RFP is almost complete for the Splash Park. Bidders will be allowed to bid materials, installation or both.

Nate Williams' travels recently took him to Northwest Missouri State University to talk to a Foundations of Recreation class. He also informed the class that he was looking for interns.

Nate attended the Missouri Parks and Recreation Association's Legislative Workshop in Jefferson City. At the workshop, attendees learned what the Missouri Legislature will be taking action on next session. One of the topics was when a trail or park is built and the users wander off into private property and the liability thereof. He will be attending the Legislature Action Day in January.

Nate also attended the MPRA Board meeting in Jefferson City.
