Jake Simmons, as President, serves as an ex-officio member of all committees.

#### **OLD BUSINESS**

Nate Williams will set up a joint meeting between the Excelsior Springs Parks Foundation and the Excelsior Springs Parks and Recreation Board to discuss and review plans for the Milwaukee Street Park since this is a project that the Foundation is funding.

#### **NEW BUSINESS**

Apparel bids were discussed. These are the shirts for the youth programs, adult program awards, special events and staff.

According to the Request for Bids, The City of Excelsior Springs. Parks and Recreation, has the right to accept part, all or none of the specific bid.

Four companies submitted bids. Discussion continued.

Zac Wilkins made the motion to accept the bid from Hustle + Heart for the youth shirts with an estimated total of \$7,581.75. Kyle Uptegrove seconded the motion, motion passed, 7-0. ZacWilkins made the motion to accept the bid from TW Custom Apparel for adult apparel, staff and special events shirts with an estimated total of \$7,664.76. Kyle Uptegrove seconded the motion, motion passed, 7-0. A roll call vote was taken: Ayes -7 – Sherri Branson-Hurt, Scott Buckman, Mark Bullimore, Jessica Meyer, Jake Simmons, Kyle Uptegrove, Zac Wilkins Nays -0

The Officials bid was discussed. There was one bid submitted from Liberty Sports Officials.

Kyle Uptegrove made the motion to accept the bid from Liberty Sports Officials.to supply officials Mark Bullimore seconded the motion. Motion passed, 7 - 0. A roll call vote was taken: Ayes - 7 - Sherri Branson-Hurt, Scott Buckman, Mark Bullimore, Jessica Meyer, Jake Simmons, Kyle Uptegrove, Zac Wilkins Nays - 0

The Volunteer Background Check was discussed. National Center for Safety Initiatives LLC is recommended by the National Recreation and Parks Association. The Advanced Background check fee is \$24.95 per coach per year. If the coach coaches again the next year, there is no fee for them to be rechecked.

National Center for Safety Initiatives LLC will contact persons that do not pass the Volunteer Background Check.

Scott Buckman made the motion to approve the bid of National Center for Safety Initiatives LLC for \$24.95 per volunteer coach. Mark Bullimore seconded the motion, motion passed, 7-0. The Parks maintenance truck was discussed. A 2023 Ford F350 XL truck with dual rear wheels, snow plow prep package, gasoline with a 9'4" diamond series flatbed for \$58,244.00 has been located in Iowa. There is a trade-in value of \$15,000 for the 2013 Ford Super Duty F-250 truck. Cost of the 2023 Ford F350 truck with trade-in is \$43,244.00.

The truck is at Karl Ford in Story City, Iowa.

Zac Wilkins made the motion to approve the purchase of the 2023 Ford F350 XL truck from Karl Ford for \$58,244.00 less the trade-in value of \$15,000 for the 2013 Ford Super Duty F-250 truck for a total cost of \$43,244.00.
