OLD BUSINESS

Discussion was held on the purchase of land for Rainbow Splash Park from the United Methodist Church.

Patrick Halfhill made the motion to purchase the land for \$20,000 from the United Methodist Church, to be paid in the FY 24-25 Budget year - after October 1, 2024 and split the additional costs, i.e. surveying, etc. 50/50 with the Methodist Church.

NEW BUSINESS

Nate Williams talked to the Board about CivicPlus. It is a Social Media Archiving company. Civic Plus will archive all social media exposure. Social media is subject to Missouri's Sunshine Law.

Jake Simmons arrived at 6:29 p.m.

The Excelsior Springs Police Department did a trial subscription with CivicPlus. They decided to add a paid subscription. Excelsior Springs Parks and Recreation and the Excelsior Springs Community Center was invited to join. The Police Department will pay half of the subscription cost and a quarter of the cost will be paid by Parks and Recreation and a quarter paid by the Community Center.

There is no need for a motion or vote because the cost is within the parameters of Nate William's approval.

Nate Williams, Drake Pollard, and Alexis Blankenship gave reports on their attendance at the Missouri Parks and Recreation Association Conference. They came away with good information - training empowers staff, evaluations, accountability, etc. Complete reports are in the March 2024 Board packet.

Alexis Blankenship was elected Secretary/Treasurer of the Young Professionals Section of the Missouri Parks and Recreation Association.

As the Excelsior Springs Parks, Recreation and Community Center continues to evolve, a new position has been added to the Excelsior Springs Parks, Recreation and Community Center leadership team - Assistant Director: Administration. Taran Svoboda has been hired for this position. She will start June 1, 2024.

The maintenance crew is still looking for full and part time workers.

The trailer purchase was discussed. This new 16' trailer will replace a 2010 Scott's

Custom model. It is a few years past the replacement rotation. The cost is higher than what is budgeted but the proceeds from the sale of the grasshopper mower will offset that cost. All the bids were through Sourcewell. The 2010 model trailer will be sold on PurpleWave.

Discussion was held.

Sherri Branson-Hurt made the motion to purchase a 16' Felling trailer (FT-16-IT-I) from Murphy Tractor, Kansas City, MO for \$17,024.00 Patrick Halfhill seconded the motion, motion passed, 6 - 0.
