The parking lot plans have been submitted to Planning and Zoning for approval. After the parking lot plans receive approval from the Planning and Zoning infrastructure will begin - dirt will be moved, water, sewer and electrical will be installed. The Department will utilize a purchasing coop to purchase park structures, etc.
